Embry-Riddle Aeronautical University-Worldwide-Yellow Ribbon Scholarship application



The Yellow Ribbon GI Education Enhancement Program (YRP) is a provision of the Post-9/11[®] Veterans Educational Assistance Act of 2008. Only individuals entitled to the maximum benefit rate (based on service requirements) may receive Yellow ribbon funding. Therefore, you may be eligible if:

- You served an aggregate period of active duty after September 10, 2001, of at least 36 months;
- You were honorable discharged from active duty for a service connected disability and served 30 continuous days after September 10, 2011;
- You are dependent eligible for Transfer of Entitlement under the Post-9/11 GI Bill[®] based on a veteran's service under the eligibility criteria listed above.

The Department of Veterans Affairs (VA) will determine eligibility for the Post-9/11 GI Bill[®], and issue a Certificate of Eligibility. The Certificate of Eligibility will advise you if your service meets the requirements for the Yellow Ribbon Program. Embry-Riddle Aeronautical University (ERAU) has volunteered to participate in the Yellow Ribbon Program. Therefore, you must submit this application along with: **1.** your certificate of eligibility and **2**. Complete the request to certify your enrollment online for your campus Veterans' Program administrator.

Post-9/11 GI Bill[®] benefits are payable for training pursued on or after August 1, 2009. Yellow Ribbon Scholarship are payable for enrollment periods beginning on or after August 1, 2009.

The amount of the Embry-Riddle Aeronautical University Yellow Ribbon Scholarship for attendance at Worldwide locations will be equal to 50% of the unmet tuition and fees for each enrollment period. You will be notified of the annual award for each academic year.

ERAU agrees to participate in the Yellow Ribbon Program under the Post-9/11 GI Bill[®] (authorized under Title V of Public Law 110-252) subject to the terms, conditions, and representation provided in the YRP agreement and applicable VA regulations.

- ERAU Worldwide agrees to provide contributions to 7,000 eligible individuals who apply for the Yellow Ribbon Program on a first-come first-serve basis, regardless of the rate at which the individual is pursuing training (i.e., full time versus less than full time), during the academic year listed below.
- ERAU agrees to provide contributions on behalf of a participating individual during the current academic year and all subsequent academic years in which Embry-Riddle participates in the Yellow Ribbon Program, provided that the individual maintains satisfactory progress, conduct, and attendance according to the regularly prescribed standards of ERAU.
- ERAU agrees to limit contributions made on behalf of a participant to funds under the restricted control of Embry-Riddle (e.g., a scholarship sent directly to Embry-Riddle on behalf of an individual or specific group of individuals from a third party may not be included in Yellow Ribbon Program contributions). Funds received directly or indirectly from Federal sources may not be counted toward contributions.
- ERAU agrees to provide the maximum amount of contributions payable toward the unmet established tuition charges to each participating individual during each semester/term the individual is enrolled; if Embry-Riddle's total contribution toward the individual's unmet established tuition charges for the semester/term do not exceed the maximum dollar amount payable during the academic year.
